



Chapter By-laws of the Robert B. Glenn High School Chapter of the National Honor Society

National Honor Society By-Laws Robert B. Glenn High School

- I. Attendance at meetings and National Honor Society inductions is mandatory, except for cases in which the student is absent for the whole day, plays on school team which has an away game/match, or has an AP exam. Students alleging appointments elsewhere must provide the doctor's phone number for verification of excused absence. Note Notes from home will not suffice to excuse an absence, nor will the demands of the student's employer. Participation in the service project voted on by the society is mandatory. Students will be warned after one unexcused absence and placed on probation after two unexcused absences in the same school year.
- II. Students will be placed on probation for nine weeks (or in the case of nos. 1 & 3, until next report card) for the following reasons:
 - 1) receiving an N in conduct
 - 2) being referred to the office for disciplinary action (D-1) for a non-honor offense (e.g. undirected use of inappropriate vocabulary, dress code violations)
 - 3) excessive tardiness to or absences from school
 - 4) assignment to detention or ISS
 - 5) excessive unexcused absences from NHS meetings (see I

above)

- 6) failure to pay dues
- 7) failure to participate in either NHS service project or the fund-raiser(s) conducted in support thereof
 - 8) skipping class(es)

9) any other infraction deemed deserving of nine weeks' probation by majority of the faculty council

The probation period is as a redemptive opportunity for the student. (S)He is expected to learn from this experience and rectify the problem behavior. A written apology to the individual(s) involved may also be required.

III) Students will be put on a longer probation and/or be dismissed from membership in National Honor Society

(following a hearing before the faculty Council) for the following reasons:

- documented Honor offense (i.e. stealing, forgery, cheating lying)
- **2)** receiving a U in conduct
- **3)** receiving more than one N in conduct (cumulative)
- 4) serious disciplinary infractions (i.e. fighting, smoking, blatant disrespect to GHS staff, significant classroom disruption)
- 5) second probation (be it for the same or different causes)
- **6)** criminal conviction
 - 7) any other infraction deemed deserving of dismissal by majority of the faculty council
- **IV)** After class rank has been computed, students will be warned in writing if they fall below the academic standard (3.25 unweighted GPA) which was the basis for NHS selection. Failure to bring the unweighted GPA back up to a 3.25after one semester will result in automatic dismissal from membership in National Honor Society.
